- bedrijven die kernwapens produceren of specifieke, belangrijke onderdelen daarvan;
- clusterbommen, landmijnen, chemische- en biologische wapens;
- staatsobligaties van landen waarvoor een VN-veiligheidsraad wapenembargo van kracht is.
